**NOTICE OF WITHDRAWAL OF
APPLICATION FOR AMENDMENT OF CERTIFICATE**

Applicant, WEST LAKE LAND WASTEWATER, INC., ("West Lakeland," "Service Company" or "Utility") by and through its undersigned attorneys hereby withdraws its Application for Amendment of its wastewater certificated territory in Polk County, Florida and in support thereof states as follows:

1. On July 26, 2005, West Lakeland filed its Application for Amendment of its Wastewater Certificate in Polk County, Florida with the Florida Public Service Commission.
2. As a result of changes which occurred after that filing within the proposed extension area, the Utility requested that this matter be held in abeyance while it determined whether or not moving forward with the extension of territory in the form originally requested was appropriate, or whether other changes needed to be made to that Application.
3. The Utility has now determined that moving forward with the extension of service territory as originally filed is not appropriate given the changes in circumstances that have occurred.




