RE: Docket No. 060040-TI – Acknowledgement of cancellation of IXC Registration No. TJ198 by Startec Global Licensing Company, of IXC registration by STARTEC Global Operating Company, and of adoption of Startec's tariff by STARTEC, effective January 18, 2006.

On January 18, 2006, this Commission received contact information from STARTEC Global Operating Company (Global Operating) with a request to adopt Startec Global Licensing Company's (Global Licensing) tariff upon customer base transfer to Global Operating, and acknowledgment of the cancellation of Global Licensing's IXC Registration No. TJ198, and subsequent removal from the IXC Registration List.

After a review of the application, and the request to adopt the existing Global Licensing company tariff post cancellation, staff believes the proposed tariff adoption would not adversely affect customers as Global Operating will continue to provide the same services that are currently provided by Global Licensing. Global Operating should be allowed to adopt the current Global Licensing's tariff on file with the Commission. The transferring customers will retain the same rates, terms, and conditions of service as currently provided by Global Licensing.

Staff has determined that the documents received meet the requirements of Section 364.02(13), Florida Statutes.

STARTEC Global Operating Company is assigned TK051, as an IXC registration number for the state of Florida. As required by Section 2.07.C.5.h., Administrative Procedures Manual, Global Operating has provided the required contact information and intent to adopt the existing Global Licensing's company tariff. STARTEC Global Operating Company should be acknowledged as registered intrastate interexchange telecommunications company effective January 18, 2006.

Startec Global Licensing Company has paid their 2005 and 2006 regulatory assessment fees as required in Section 364.336, Florida Statutes. Startec Global Licensing Company's, IXC Registration No. TJ198 can be removed from the IXC Registration list.

Accordingly, with this Memorandum, Docket No. 060040-TI should be closed.
