

(collectively "KMC") and Sprint-Florida, Incorporated ("Sprint-FL") and Sprint Communications Company Limited Partnership ("Sprint LP"), pursuant to Rule 28-106.204, Florida Administrative Code, hereby move the Florida Public Service Commission (hereinafter "Commission") to extend the time testimony is due in this docket. As grounds therefore, KMC, Sprint-FL and Sprint LP state:

1. Commission Order No. PSC-06-0054-PCO-TP issued January 23, 2006, set the due date for direct testimony as February 20, 2006 and the due date for rebuttal testimony as March 20, 2006.
2. On February 16, 2005 KMC, Sprint-FL, and Sprint LP requested a one-week extension of the due date for direct testimony which was granted by Order No. PSC-06-0367-PCO-TP issued February 20, 2006. The Parties have continued to negotiate to resolve various issues and believe that a further extension will facilitate the settlement process.
3. The requested extension will not impact the hearing date currently set in this docket.




