**Amendment to the Interconnection Agreement
Between
Verizon Avenue Corp. and
BellSouth Telecommunications, Inc.
Dated November 24, 2005**

This Amendment is entered into by and between Verizon Avenue Corp. (Verizon Ave) and BellSouth Telecommunications, Inc. ("BellSouth") hereinafter referred to collectively as the "Parties," to amend that certain Interconnection Agreement between the Parties dated November 24, 2005 ("Interconnection Agreement") to be effective as of the date of the last signature to the amendment.

WHEREAS, Verizon Ave has changed the name of said business to Verizon Avenue Corp. d/b/a Verizon Avenue (Verizon Avenue), a(n) Delaware corporation.

WHEREAS, the Parties desire that the Interconnection Agreement be amended to reflect the correct corporate entity name.

NOW, THEREFORE, in consideration of the mutual promises and covenants contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby covenant and agree as follows:

1. The name of Verizon Avenue Corp. (Verizon Ave) in the Interconnection Agreement is hereby deleted throughout the Interconnection Agreement and replaced with Verizon Avenue Corp. d/b/a Verizon Avenue (Verizon Avenue).

2. All of the other provisions of the Interconnection Agreement, dated November 24, 2005, shall remain in full force and effect.

3. Either or both of the Parties is authorized to submit this Amendment to each Public Service Commission for approval subject to Section 252(e) of the Telecommunications Act of 1996.
