Pursuant to Commission Rule 25-30.550, Florida Administrative Code, enclosed is a copy of a Wastewater Agreement entered into between North Fort Myers Utility, Inc., and Bayros, LLC, to provide wastewater service to Bayshore Commons Commercial Park. North Fort Myers Utility Inc.'s wastewater treatment plant has a permitted capacity of 3.5 mgd. The current treatment plant connected load is approximately 1.2 million gpd and this Wastewater Agreement is for 6,100 gpd. There is sufficient capacity in NFMU's existing plant to provide wastewater service pursuant to this Agreement. This Wastewater Agreement will have no noticeable impact on the Utility's rates due to the amount of demand being placed on the NFMU wastewater system, and resultant revenues.
