Image Access Communications, Inc. d/b/a NewPhone is an Alternative Local Exchange Carrier and an Intrastate Interexchange Carrier authorized to do, and doing business in the State of Florida. The Company Code for its ALEC authority is TX254, and the Company Code for its IXC authority is TJ902.

The Company has changed the name under which it operates in the State of Florida to be consistent with the name under which it operates in all other states for ease of administration and consistency. The operating name change is a matter of form only, and does not result from any changes in the Company's ownership, management or structure, which will not change as a result of the operating name change. 
