I am writing for the last time to notify the PSC AGAIN that Loch Harbour Utilities, Inc. has long since ceased doing business and that the corporation has been administratively dissolved.

The facts are these:

Loch Harbour Utilities, Inc. was sold in 2004 to Development Resources, Inc., Robert Clayton Albright, President, P.O. Box 830220, Ocala, FL 34483. Mr. Albright commenced operating the utility on June 1, 2004. He further made application to the Florida DEP on 12/09/04 relative to the transfer of the business from Loch Harbour Utilities to Development Resources, Inc. (copy attached).

The 2004 Annual Report for Loch Harbour Utilities, Inc. was filed in March, 2005 and contained notification that Loch Harbour Utilities was no longer in business and that Development Resources, Inc. was responsible for operations beginning on June 1, 2004, as noted above. Since then we have responded with the same information to several inquiries similar to the attached.

It is my understanding that Marion County's Utility Department is currently either operating or owns the utility. The point is that we are tired of receiving correspondence regarding a company which no longer exists.

Please be so kind to remove Loch Harbour Utilities, Inc. from your records permanently, as we will no longer respond to further communications from you regarding it. If you have any questions, please contact me at 352-875-0286.
