As required by Section 364.336, Florida Statutes, and Rule 25-4.0161, Florida Administrative Code (F.A.C.), you were mailed a RAF return form on December 15, 2005, and payment was due on January 30, 2006.

Because you are delinquent in payment, in addition to the RAF, which is 0.0020 of a company's intrastate revenues or a minimum fee of \$50, whichever is greater, the company must now pay late payment charges.
