## MARIPOSA UTILITY COMPANY, LLC's APPLICATION FOR WATER AND WASTEWATER CERTIFICATES

Mariposa Utility Company, LLC ("Applicant"), by and through its undersigned attorneys and pursuant to Sections 367.031 and 367.045, Florida Statutes, and Rule 25-30.033, Florida Administrative Code, hereby applies for an original certificate to operate a water and wastewater utility in Putnam County, Florida, and submits the following information:

#### INTRODUCTION:

Although the Applicant is not expected to begin service to customers until 2008, Section 367.031, Florida Statutes, requires that a utility have a certificate from the Commission before the Department of Environmental Protection and Water Management District may issue construction and operating permits.

## REQUEST TO BIFURCATE ESTABLISHMENT OF INITIAL RATES AND CHARGES:

Since Applicant will not begin to serve customers for approximately three years, it requests that the certification and rate setting processes be bifurcated so that the Certificates can be issued within 90 days as required by Section 367.031, Florida Statutes, and the Applicant may proceed with permitting for its Water Use Permit, and wastewater treatment plant construction permit. Applicant is simultaneously filing a Motion for Temporary Rule DOCCHILINI NUMBER-CATE

Waiver to implement this request for bifurcation. This bifurcation procedure was approved by the Commission in a similar situation in In re: Application for Original Certificate to Operate Water and Wastewater Utility in Sumter County by North Sumter Utility Company, L.L.C., Order No. PSC-02-0179-FOF-WS (February 11, 2002), and In re: Application for Certificates to provide Water and Wastewater Service in Sumter County by Central Sumter Utility Company, L.L.C., Order No. PSC-05-0844-PAA-WS (August 18, 2005).

Applicant will file Tariffs and the financial schedules to establish initial rates, charges and return on equity sufficiently in advance of when Applicant becomes operational for the Commissioners' timely review.

PART II: NEED FOR SERVICE

- A. The territory proposed to be served by Applicant consisting of 2,061 acres is owned or controlled by a related party which intends to develop the property as a Development of Regional Impact with a "village center" concept. There are no other water and wastewater utilities nearby which have indicated an ability and a willingness to provide water and wastewater service in the proposed service territory.
- B. To the best of Applicant's knowledge, the provision of service is not consistent with the water and wastewater sections of local comprehensive plan, as approved by the Department of Community Affairs, and the development will require a Comprehensive Plan amendment. However, Putnam County has indicated that the eastern portion of the County where this proposed development is to be located should be reviewed with an effort to establish a special area plan for growth in that area of the County.

#### PART III: SYSTEM INFORMATION

#### A. WATER AND WASTEWATER

(1) The Applicant proposes to provide potable water and wastewater service within the entire service area, and treated effluent will be used for irrigation which sufficient quantity is available.

(2) There are projected to be 3,046 residential ERCs utilizing 5/8" x 3/4" water meters. The commercial development is proposed to require 320 ERCs. The following is a description of the type of customer to be served:

#### **Residential Customers**

Residential customers will consist of conventionally built singlefamily detached and attached homes, and multi-family residences.

#### **Commercial Customers**

The primary types of commercial customers anticipated to be served include offices, retail stores, and restaurants. Additional supporting uses may include institutional/educational uses, medical facilities, and recreational facilities.

(3) The following is a description of the capacities of Applicant's lines and treatment facilities:

#### Water

The proposed capacity of the water treatment plant and associated distribution system will be designed and constructed to supply the maximum daily demand plus peak hourly flows.

#### Wastewater

The proposed capacity of the wastewater treatment plant and associated collection system will be designed and constructed to accept the maximum month average daily demand.

- (4) Attached as Exhibit "A" is a description of the water and wastewater treat treatment facilities.
  - (5) When the location of the plant sites has been determined, Applicant will

provide a copy of a Warranty Deed by which the Applicant will acquire the real estate upon which the water and wastewater plants are to be located, as Late Filed Exhibit "B".

#### PART IV: FINANCIAL AND TECHNICAL INFORMATION

- A. (1) Financial Ability. The Applicant is an affiliated party of the developer of the service area and, as such, will provide necessary start up funding as well as funds sufficient to cover operation shortfalls during its initial years of inception. Attached as Exhibit "C" is the manner in which the construction of the water and wastewater facilities will be funded.
  - (2) Technical Ability. The Applicant has retained the following professionals with regard to the construction, operation and regulation of its water and wastewater systems:

B. A Special Report to be prepared by Cronin, Jackson, Nixon & Wilson setting forth the required financial information will be filed in the rate setting phase of this Docket.

#### EXHIBIT "A"

The raw water will be drawn from the Floridan Aquifer through 3 wells. The raw water will be treated using membrane treatment technology. The finished water will be chlorinated and distributed to customers. The membrane concentrate will be pumped to the on-site WWTP for further treatment. The wastewater generated will be collected and treated using conventional preliminary screening and grit removal, primary treatment, and then an aerobic secondary treatment unit. The finished effluent will achieve re-use quality standards through membrane bioreactor technology, then chlorinated before being used for irrigation. The sludge will be digested and stabilized to meet Grade B parameters, then hauled via truck for use on local sod farms.



# **Putnam County Online Map**


