We are the attorneys for Axis, Inc. d/b/a Axis Communications ("Axis" or "Company"). The Commission previously authorized Axis to provide intrastate telecommunications services in Docket Number 030989-TI, Company Number TJ850. Axis has no customers and no longer intends to retain authority in the State of Florida. Accordingly, we respectfully request that, effective immediately, the Commission remove Axis from the Florida IXC register.

Axis previously sent the Commission a copy of an FCC filing, which the Commission received on June 20, 2005 and expressed the Company's intent to discontinue providing long distance service throughout the United States, including Florida. We have just recently learned that because the request was not made specifically to the Florida Public Service Commission, the company is still listed as active and has subsequently been assessed the \$50 RAF. As such, a check for \$50.00 is enclosed to cover the RAF.
