Request for Permission from Department of Financial Services to Write-Off the Uncollectible RAFs for 2005 on Comm South Companies, Inc. d/b/a Florida Comm South's IXC registration and CLEC certificate, and the statutory late payment charges for the year 2004 for the company's IXC registration and CLEC certificate.

On September 22, 2005, Docket No. 050632-TP was established to address the cancellation of Comm South Companies, Inc. d/b/a Florida Comm South's intrastate interexchange telecommunications (IXC) Registration No. TJ480 and competitive local exchange carrier (CLEC) certificate No. 7742 due to Chapter 7 bankruptcy.

By Order No. PSC-06-0099-PAA-TP, the Commission granted cancellation of Comm South Companies, Inc. d/b/a Florida Comm South's IXC Registration No. TJ480 and CLEC Certificate No. 7742, effective December 31, 2005. The Commission further ordered that the Division of the Commission Clerk and Administrative Services shall be notified that the 2005 Regulatory Assessment Fees (RAFs) for the company's IXC registration and CLEC certificate, and the statutory late payment charges for the year 2004 for the company's IXC registration and CLEC certificate shall not be sent to the Department of Financial Services for collection, instead permission for the Commission to write-off the uncollectible amounts will be requested.

Therefore, staff requests that the Bureau of Administrative Services and Fiscal Services Section take the appropriate steps to seek permission from the Department of Financial Services to write-off the uncollectible RAFs for 2005 for the company's IXC registration and CLEC certificate, and the statutory late payment charges for the year 2004 for the company's IXC registration and CLEC certificate.
