The name change is being undertaken to enable Applicant to simplify and to align its legal corporate name with how Applicant is today identified to, and recognized by, its customers and the general public and as furthered described below.

**A. Description of Applicant**

**C. CORPORATE NAME CHANGE**

On February 21, 2006, ITC^DeltaCom filed in the Probate Court of Marshall County, Alabama, an Articles of Amendment to Articles of Incorporation changing its name to DeltaCom, Inc., as was duly approved by the company's Board of Directors. Adoption of DeltaCom, Inc. as Applicant's legal corporate name was certified by the Office of the Secretary of State of the State of Alabama, Applicant's State of incorporation, as evidenced by the Alabama Secretary of State's Certificate of Authority, attached hereto as Exhibit A. Applicant has further registered its new corporate name with the Florida Department of State, as evidenced by the State registration documents attached hereto as Exhibit B.

The purpose of Applicant's name change is to enable Applicant to simplify and to align its legal corporate name with how Applicant is today identified to, and recognized by, its customers and the general public. The requested name change authority exclusively entails a change in legal corporate name and is not sought in conjunction with any merger, acquisition, consolidation or other change in corporate structure or ownership that would require separate Commission authority.

Applicant requests that the Commission change the certificates of public convenience and necessity held by ITC^DeltaCom Communications, Inc. to reflect the name change to "DeltaCom, Inc." The applicable revised tariff sheets and tariff labels are being provided with this notice as Exhibit C in accordance with instructions from Staff. As future tariff revisions are submitted, Applicant will change its name on the affected sheets for each tariff that is being revised.

**D. EFFECT OF NAME CHANGE**


The name change will have no impact on customers or services. Customers will be provided notice of the name change via written communication. A sample copy of the




