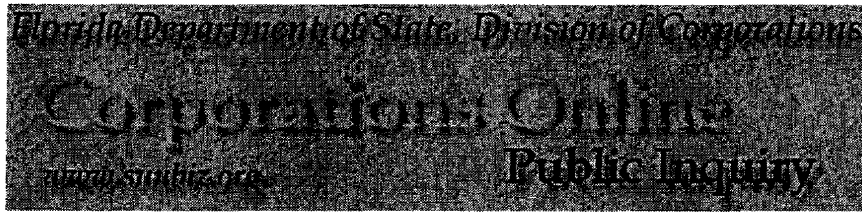

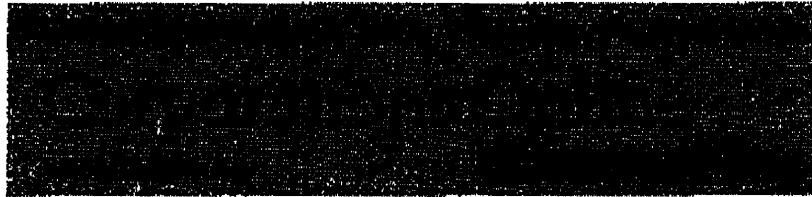

Mr. Foster,

I am an analyst with the Florida Public Service Commission and I have been forwarded an update information sheet completed by Ms. Zayas for the above company on March 24, 2006. In the mailing name area, the name "Call One" is listed for the company name. The FPSC doesn't have a name change request on file showing the d/b/a change from Florida UCS, Inc. to Call One. I also couldn't locate a fictitious Florida name for Call One associated with United Communications Systems, Inc.

It is simply an administrative request to add the new d/b/a to the registration, however, it needs to be registered in Florida first. Once the name is registered, a simple name change request letter and some new tariff labels can be mailed to the Commission for the administrative change to be made. It takes roughly 30 days for this to be completed.

As it stands now, United Communications Systems, Inc. shouldn't be using the new fictitious name in Florida. This sort of oversight happens and can be easily corrected via the above instructions. Please let me know if Call One is indeed a new d/b/a and I will hold the change sheet until you can register the name in Florida and send the administrative change request to my attention. Either way, please let me know.
