**BELLSOUTH'S MOTION FOR EXTENSION OF TIME**

BellSouth Telecommunications, Inc. ("BellSouth") asks the Florida Public Service Commission ("Commission") for an extension of time in which to file executed interconnection agreements. In support of this Motion, BellSouth states the following:

1. Pursuant to Order No. PSC-06-0172-FOF-TP, the parties were required to file executed amendments to the parties' current interconnection agreements or new interconnection agreements on March 10, 2006.

2. On April 17, 2006, the Commission issued Order No. PSC-06-0299-FOF-TP. The Order requires the parties to the Proceeding to file amendments or agreements for issues 5, 13, 16-18 and 22(b) on April 27, 2006.

3. BellSouth and the affected CLECs<sup>1</sup> need additional time to incorporate the Commission's Order into the parties' agreements.

4. BellSouth requests that the Commission extend the time to file amendments or agreements for issues 5, 13, 16-18 and 22(b) until May 30, 2006.

5. No party will be prejudiced by this request for an extension as the effective date of the amendments and interconnection agreements will be March 11, 2006.

<sup>1</sup> Affected CLECs are those CLECs that have not executed an amendment to an interconnection agreement or have executed amendments in which certain language has been vacated by the Commission.

6. BellSouth has attempted to contact a number of the affected CLECs to ascertain whether they object to the extension; however, BellSouth has not been able to contact all of the affected CLECs. Of the affected CLECs that have been contacted, they have no objection or have not responded.

WHEREFORE, for the foregoing reasons, BellSouth respectfully requests that this Commission grant it an extension until May 30, 2006 to file amendments or agreements for issues 5, 13, 16-18 and 22(b) in compliance with the Commission's Order in the instant docket.


