PLEASE TAKE NOTICE that on March 31, 2006, the above-captioned debtors and debtors in possession (collectively, the "<u>RME Debtors</u>") filed for relief under chapter 11 of title 11 of the United States Code in the United States Bankruptcy Court for the Southern District of New York.
