PLEASE TAKE NOTICE that on March 31, 2006, the above-captioned debtors and debtors in possession (collectively, the "RME Debtors") filed for relief under chapter 11 of title 11 of the United States Code in the United States Bankruptcy Court for the Southern District of New York.

PLEASE TAKE FURTHER NOTICE that, pursuant to Rule 1015 of the Federal Rules of Bankruptcy Procedure, the RME Debtors have moved for an order authorizing joint administration with the chapter 11 cases of certain of its affiliates (the "Initial Debtors") and, together with the RME Debtors, the "Debtors"), whose cases are captioned In re Adelphia Communications Corporation et al. (Case No. 02-41729)(REG).

PLEASE TAKE FURTHER NOTICE that certain of the Debtors have filed a Motion for Order Pursuant to Bankruptcy Rule 3003(c)(3) Setting a Final Date to File Proofs of Claim.

PLEASE TAKE FURTHER NOTICE that a hearing (the "Hearing") on the motions described herein will be held before the Honorable Robert E. Gerber, United States Bankruptcy Judge in Room 621 of the United States Bankruptcy Court, Alexander Hamilton United States Custom House, One Bowling Green, New York, New York 10004-1408 on March 31, 2006 at 11:00 a.m. (Prevailing Eastern Time), or as soon thereafter as counsel can be heard, at which time the Debtors will seek entry of orders substantially in the form annexed to the respective motions.

PLEASE TAKE FURTHER NOTICE that if you wish to be heard in respect of any of the foregoing matters, you must attend the Hearing. The Hearing may be continued or adjourned from time to time without further notice other than an announcement of the adjourned date or dates at the Hearing or at a later hearing.
