

**GTC, INC. D/B/A GT COM'S UNOPPOSED MOTION  
FOR EXTENSION OF TIME TO FILE  
PREFILED DIRECT TESTIMONY AND EXHIBITS**

GTC, Inc., d/b/a GT Com, by and through its undersigned counsel, hereby requests the Prehearing Officer to enter an Order granting GT Com an additional five days for the filing of its prefiled testimony and exhibits. In support of this Motion, GT Com states as follows:

1. Pursuant to the Order Establishing Procedure, Order No. PSC-06-0362-PCO-TL issued April 27, 2006, prefiled direct testimony and exhibits are due May 4, 2006.
2. GT Com intends to file the prefiled direct testimony and exhibits of one witness, R. Mark Ellmer, Regional Controller - Southeast for GT Com. Due to prior commitments of Mr. Ellmer and his counsel, GT Com requests an five additional days for the preparation and filing of Mr. Ellmer's prefiled direct testimony and exhibits.
3. GT Com is mindful that the Controlling Dates set forth in the Order Establishing Procedure have been established to allow the completion of this proceeding within the applicable statutory time frame, including the requirement that discovery responses be served within fifteen days. Staff has advised that it does not object to GT Com's requested five day extension so long as GT Com agrees to provide its responses to Staff's next set of discovery requests arising from the filing of prefiled direct testimony and exhibits within ten days, rather than within fifteen days as required by the Order Establishing Procedure. GT Com hereby agrees to Staff's request.




