**NOTICE TO CUSTOMERS OF FEES AND CHARGES OF  
GOLD COAST UTILITY CORP.**

On December 1, 2005, Gold Coast Utility Corp. (*Gold Coast*), filed an application for transfer of the water and wastewater facilities and certificates of Lake Haven Utility Associates, Ltd., d/b/a Lake Wales Utility Company to Gold Coast, and for authority to charge an increased meter installation fee and a late payment charge.

At the Agenda Conference held on April 4, 2006, the Commission took action on Gold Coast's application. By Proposed Agency Action Order Approving Change in Rates and Final Order Approving Transfer, the Commission authorized Gold Coast to charge a meter installation fee of \$170.00 and a late payment charge of \$5.00.

The approved fee and charge are effective for service on or after the stamped approval date on the tariff.

A comparison of the current and newly-approved meter installation fee and late payment charge are as follows:

\* The increased Meter Installation Fee will be effective immediately for all new customers requesting service and does not apply to existing customers of Gold Coast.
