

**PROTECTION PLUS OF THE FLORIDA KEYS, INC. DBA ENGAGE

REQUEST FOR SPECIFIED CONFIDENTIAL CLASSIFICATION**

Protection Plus of the Florida Keys, Inc. dba Engage Communications pursuant to Rule 25-22.006, Florida Administrative Code, files this First Request for Specified Confidential Classification.

1. On or about January 18, 2006 Protection Plus of the Florida Keys, Inc. dba Engage Communications filed an Application to provide Competitive Local Exchange Services with the Florida Public Service Commission. Attached to that filing were the financial statements of Protection Plus of the Florida Keys, Inc. dba Engage Communications. The company considers those attached financial statements containing information that is confidential proprietary business information concerning the financial affairs of the company.

2. Because the Application contained information that is confidential and proprietary, Protection Plus of the Florida Keys, Inc. dba Engage Communications now files this Request for Confidential Classification pursuant to Rule 25-22.006(3)(a), Florida Administrative Code, in order to allow the Commission to take possession of the Confidential Information without delay.

3. Section 364.183, Florida Statutes, provides an exemption from the disclosure requirements of section I 19.07, Florida Statutes, when disclosure of confidential business information would "impair the competitive business of the provider of the information." Disclosure of the information provided with the Application to provide Competitive Local Exchange Services would harm Protection Plus of the Florida Keys, Inc. dba Engage Communications' competitive interests by placing details of its business operations in the public domain. Accordingly, the information should be exempt from the public disclosure requirements of section 119.07, Florida Statutes. Further, Protection Plus of the Florida Keys, Inc. dba Engage Communications Covad considers and treats this information as confidential and proprietary. A more specific description of the exhibit information is described in Attachment A.

Explanation of Proprietary Information

1, The copies (previously submitted originals attached to the CLEC application, and in the possession of the PSC) contain **CONFIDENTIAL** information regarding the financial condition of Protection Plus of the Florida Keys dba Engage Communications. This information is related to Protection Plus of the Florida Keys dba Engage Communications' ongoing business affairs and operations and can be used by competitors to harm competitive interests. Section **364.183**, Florida Statutes, allows for an exemption from the disclosure requirements of section **19.07**, Florida Statutes, when disclosure would "impair the competitive business of the provider of the information." Therefore, the information should be shielded from disclosure pursuant to section **19.07**, Florida Statutes **and** section **24 (a)**, **Art. 1** of the State Constitution.
