Dear Ms. Bayo:

As previously reported, CBC, an authorized telecommunications carrier in Florida,¹ recently completed an internal restructuring and converted from a corporation to a limited liability company. In conjunction with that transaction, CBC was required to submit updated paperwork to continue using the fictitious name “Comcast Long Distance,” under which its services have been marketed for many years. Enclosed, for your information, is a copy of the authorization from the Secretary of State for Comcast Business Communications, LLC, (“CBC”) to continue using its trade name “Comcast Long Distance.”

The Commission approved this reorganization and name change in Docket No. 06-0120-FOF-TP on February 23, 2006. The trade name paperwork enclosed with this filing is *pro forma* in nature and does not entail any changes to the trade name under which CBC has always marketed its services to its customers. Accordingly, CBC does not believe prior customer notification of the continued use of its fictitious name is required.

CBC understands that the Commission must approve the use of this fictitious name. Accordingly, CBC respectfully requests such approval. To the extent that customer notification is required, CBC respectfully requests a waiver on the grounds that it would be needlessly confusing to customers and unnecessarily burdensome for CBC to notify its customers of the continued use of its long-established trade name. Additionally, CBC previously submitted its stickers for its tariff with this fictitious name on it in its initial filing.


