Counsel is to advise this Court ninety (90) days from the date of this order, and every ninety (90) days thereafter, of the status of the above cited federal proceeding.

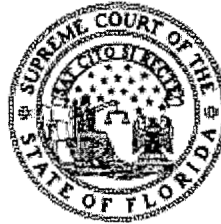
