SECTION 63.71 APPLICATION

The Utilities Commission, New Smyrna Beach ("UCNSB"), through its undersigned counsel, hereby files this Application to discontinue domestic telecommunications services pursuant to Section 63.71 of the Commission's Rules, 47 C.F.R. § 63.71, and Section 214 of the Communications Act of 1934, as amended, in the selected areas defined herein. Specifically, UCNSB seeks to discontinue the provision of certain local, domestic and international long distance,¹ and toll free services to retail customers throughout the states of Florida, Georgia, Mississippi, North Carolina, South Carolina, and Tennessee beginning August 1, 2006.² In

I. Description of Discontinuance

1. Name and address of carrier

2. Date of planned service discontinuance:

The anticipated date for the initiation of discontinuance of service in the service markets described in paragraph 3 below is August 1, 2006, or as soon thereafter as the necessary state and federal regulatory authorizations have been obtained.

3. Points of geographic areas of service affected

By this Application, UCNSB seeks authority to discontinue the provision of domestic telecommunications services provided to customers in the states of Florida, Georgia, Mississippi, North Carolina, South Carolina, and Tennessee.

4. Brief description of the type of service affected

UCNSB proposes to discontinue the provision of all local, domestic and international long distance, and toll free telecommunications services to commercial and residential retail customers in the states listed in paragraph 3, above.

5. Brief description of the dates and methods of notice to all affected customers

Written notice of the discontinuance, substantially in the form of the sample letter attached as Exhibit A (sent to customers in Florida, Georgia, North Carolina and South Carolina), Exhibit B (sent to customers in Mississippi) and Exhibit C (sent to customers in Tennessee) was mailed to all affected customers on May 31 and June 1, 2006. The customer notice letters were prepared in accordance with the requirements of Section 63.71(a) of the Commission's Rules and state rules, as applicable.

6. Non-dominance of the carrier with respect to the service to be discontinued

UCNSB is non-dominant with respect to the services that it proposes to discontinue.

7. Service

In accordance with Section 63.71(a) of the Commission's rules, UCNSB has mailed a copy of this application to the Governor and the public utility commission of each of the states listed above in paragraph 3, and to the Special Assistant for Telecommunications for the Secretary of Defense.

II. Circumstances of Discontinuance


As part of UCNSB's plan to realign its business plan in order to maintain long term economic viability, UCNSB has determined to discontinue the provision of telecommunications services in Florida, Georgia, Mississippi, North Carolina, South Carolina, and Tennessee, as described above.

III. Conclusion

UCNSB believes that the proposed discontinuance is reasonable and necessary. UCNSB will take all reasonable steps, to the extent it is able, to ensure that the discontinuance of service is not unduly disruptive to the present or future public convenience and necessity. For the foregoing reasons, UCNSB respectfully requests, pursuant to Section 214(a) of the Communications Act of 1934, as amended, 47 U.S.C. § 214(a) and Section 63.71 of the Commission's Rules, that the Commission permit it to discontinue the provision of services to customers as requested herein.


