This proceeding shall: (1) allow FPL to present evidence and testimony in support of its petition for a determination of need for its proposed transmission line; (2) permit any intervenors to present testimony and exhibits concerning this matter; (3) permit members of the public who are not parties to the need determination proceeding the opportunity to present testimony concerning this matter; and (4) allow for such other purposes as the Commission may deem appropriate.

The proceedings will be governed by the provisions of Chapter 120, Florida Statutes, Section 403.537, Florida Statutes, and Chapters 25-22 and 25-106, Florida Administrative Code.
