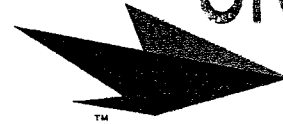

This letter is to notify the Commission that Embarq Florida, Inc. (Embarq) is dropping the d/b/a Sprint Florida from its certificated name. Embarq requests that ILEC Certificate No. 22, currently in the name of Embarq Florida, Inc. d/b/a Sprint Florida, be changed to reflect the new name.

The official separation of Embarq Corporation from Sprint Nextel Corporation occurred May 17, 2006 and the market launch occurred on June 5, 2006. Embarq filed new tariffs reflecting the Embarq Florida, Inc. name effective June 5, 2006.
