Pursuant to ¶ 101 of the Report and Order and Notice of Proposed Rulemaking ("Order") issued in the above-referenced Docket on September 23, 2005, DSLnet Communications, LLC ("DSLnet") hereby provides notice of its planned discontinuance of interstate special access DSL service used for high-speed Internet access in selected areas of the State of Florida. DSLnet will discontinue its provision of this service as a telecommunications service to the affected customers on or after July 17, 2006, but is hopeful that most if not all of these customers will continue to receive uninterrupted service by other arrangements. In accordance with the Order, DSLnet provides the following information:

### 1. Name and Address of the Carrier

## 2. Date of Planned Service Discontinuance

DSLnet plans to discontinue the provision of DSL telecommunications services to the affected customers on July 17, 2006.

## 4. Brief Description of the Type of Service Affected

The service to be discontinued is a facilities-based interstate special access DSL service which is used as the underlying broadband transmission for high-speed Internet access.

# 5. Brief Description of the Dates and Method of Notice to all Affected Customers

DSLnet provided a written customer notice via US Mail on June 14, 2006, in accordance with the requirements of CC Docket No. No 02-33, including the substance of the information set forth in numbered paragraphs 1-4 above. A copy of the form of such customer notice is attached hereto as *Exhibit A*.

## 6. Regulatory Notices

DSLnet has mailed a copy of this notice to the Governor of Florida, the Florida Public Service Commission (PSC), and the Special Assistant for Telecommunications for the Secretary of Defense.

As the service to be discontinued is interstate in nature pursuant to GTE Telephone Operating Cos., GTOC Tariff No. 1, Trans. No. 1148, 13 FCC Rcd. 22,446 (1998), DSLnet has not sought approval for the proposed discontinuation of service from the Florida PSC. DSLnet's provision of this notice to the Florida PSC is for informational purposes only. DSLnet does not propose to discontinue the provision of any intrastate service and does not seek to cancel or amend any existing state license or tariff.

Dear Customer,

DSLnet Communications, LLC ("DSLnet") regrets to inform you that on and as of July 17, 2006, DSLnet will no longer be providing broadband service at the address specified above. Accordingly, you will need to contract with an alternative provider for your broadband service and have such service up and running by July 17, 2006, to ensure that you do not encounter any disruption to your business when your broadband service with DSLnet is discontinued.

To assist you in your efforts to obtain broadband service from an alternative provider, we have set forth below specific information on the circuit that we ordered from the Telephone Company that supports your current DSL service. Should you find a provider that is able to re-use this circuit (through an industry process known as a CLEC to CLEC Migration), please be advised that this letter will serve as our irrevocable permission to release such circuit to your new broadband provider. As you are aware, the process of procuring and having installed and tested broadband service with any provider may take several weeks. Accordingly, we would recommend that you begin your process of finding an alternative broadband provider as soon as possible so that you have sufficient time to complete your transition before July 17, 2006.
