Dear Ms. Bayo:

Pursuant to Commission Rule 25-30.550, Florida Administrative Code, enclosed is a copy of a Water Utility Agreement (*Agreement*) entered into between Lake Utility Services, Inc. (*Utility*) and Sawmill Cove Development, LLC (*Developer*). Pursuant to the Agreement, the Utility will provide water service to 24 single-family homes.

The Utility's water treatment plant has a total permitted capacity of 32,194 ERCs. The connected load for the Utility's water treatment plant is approximately 9,491 ERCs. The Agreement provides for water service to 24 ERCs. Obviously, there is sufficient capacity in the Utility's existing plant to provide water service pursuant to this Agreement.

The provision of water service under this Agreement will have no noticeable impact on the Utility's rates due to the small amount of demand being placed on the water system, and resultant revenues.

In accordance with the aforementioned Rule, we will deem this Agreement approved


