The adoption filed in 060039-TP was a pure adoption and noted in its letter the underlying agreement was attached. The underlying agreement was not attached, and since this was a pure adoption wasn't necessary. Since this was a pure adoption, it was presumptively valid upon receipt by operation of law. The letter indicated the companies would be filing amendments within 30 days to reflect FCC orders and recent Commission decisions related to the TRRO and Collocation.

After discussing the discrepancy in the letter (no agreement attached) with Sprint, the Company determined it would be easier to file the underlying agreement than it would be to gather the signatures for a corrected transmittal letter. Staff believed Sprint intended to file the underlying agreement that wasn't initially filed. In fact, Sprint filed a \*new\* agreement which was assigned Docket No. 060137-TP. (On 2/14/2006, Sprint filed a "Notice of adoption of KMC Telecom V and Sprint-Florida, Incorporated Interconnection, Unbundling, Collocation and Resale Agreement with Amendments by Pac-West Telecomm, Inc." This filing is the original adoption with the amendments incorporated as part of the filing. CCA assigned Docket No. 060137-TP to this filing.)

I will be filing a memo to close DN 060039-TP today; when I prepare the memo for 060137-TP, I will reference the earlier docket and note that it superseded DN 060039-TP.
