
Dear Ms. Gervasi:

On June 5, 2006, Gistro, Inc. ("Gistro"), the applicant in this docket, filed a Notice of Withdrawal of Application ("Notice of Withdrawal"). In response to that filing, Staff requested and noticed an informal meeting which was held on June 16, 2006. At this meeting, Staff asked Mr. Holzberg, President of Gistro, essentially, what action he intended to take concerning undeveloped lots in the subdivision which is served by his collection system in the event those lots were developed. Mr. Holzberg had no specific plan as to those lots. He does know that without a PSC certificate of authorization and approved connection charge, he may not charge a connection fee to any developer or resident.

My understanding is that before Staff issues a recommendation to the Commission to acknowledge withdrawal of the Application and close the docket, it would like a firmer understanding of Gistro's future plans with regard to any undeveloped lots. At present, those plans are unknown. However, firm plans are being formulated. It is Gistro's belief that during the next 90 days, these plans will be formulated such that a firm plan may be conveyed to Staff. It is Mr. Holzberg's intent to use the upcoming 90 day time period to accomplish this result. It is Gistro's suggestion that its Notice of Withdrawal not be brought to agenda until October 17, 2006, so that it will have sufficient time to resolve Staff's concerns.
