Dear Ms. Bayo:

Electric Lightwave, LLC ("ELI"), by and through undersigned counsel, hereby advises the Florida Public Service Commission ("Commission") of ELI's intention to adopt the "doing business as" ("d/b/a") name Integra Telecom and to operate under that name in Florida. For the reasons set forth below, ELI respectfully submits that the proposed d/b/a will enable ELI to better integrate its product offerings with its sister Integra operating companies and thereby prevent customer confusion. As a result, the proposed change in the name under which ELI operates will serve the public interest.

ELI understands that formal Commission approval of its proposed d/b/a is not required. As a result, ELI submits this filing to inform the Commission, to ensure the accuracy of the Commission's records, and to update ELI's records on file with the Commission.

I. Electric Lightwave, LLC

ELI is a provider of integrated local telephone, data, network, and long distance services. ELI generally offers local, long distance and high-speed broadband transport via a fiber optic network that extends to population centers in major metropolitan areas. In Florida, ELI is authorized to provide interexchange services pursuant to registration acknowledged in Docket No. 040323-TI, on May 12, 2004.

Recently, ELI advised the Commission of a transaction whereby ELI will become a wholly owned subsidiary of Integra Telecom Holdings, Inc. ("Integra Holdings"). ELI notified the Commission of that change in ownership by letter dated March 31, 2006.

Integra Holdings, through its various operating companies, provides facilities-based, integrated communications services, primarily to small and midsize companies located in the business centers of Minnesota, North Dakota, Oregon, Utah, and Washington. Other than through ELI, however, Integra does not hold authority to provide regulated services in Florida.

III. Use of a "D/B/A" Name

In connection with the proposed acquisition of ELI by Integra Holdings, the two companies are working to better integrate and coordinate ELI's operations with those of the Integra operating companies. Accordingly, ELI now proposes to adopt the d/b/a Integra Telecom and operate under that name in Florida upon completion of the transaction, which is expected to occur on or around July 31, 2006. Although ELI will operate under this new d/b/a name, the Company's certificate will continue to be held by ELI and ELI's name will not be formally changed.¹

ELI emphasizes that the proposed d/b/a name will not result in any change in ELI's corporate structure and will not have any affect on the rates, terms or conditions under which ELI currently provides service.² Furthermore, ELI has initiated a program designed to ensure

The companies will file documents with the appropriate Florida agency in connection with the registration of the d/b/a name upon closing of the transaction, which is currently scheduled to occur on or around July 31, 2006. ELI will file the processed documents with the Commission upon request, once ELI has received them.

² Currently, ELI maintains a tariff on file with the Commission in connection with the services it renders. Attached as Exhibit A are an adoption notice and sixty (60) labels reflecting the new d/b/a name for that tariff, to be effective upon closing, which is currently scheduled to occur on or around July 31, 2006. ELI respectfully requests that the Commission append the adoption notice and labels to the Company's tariff.

that all of ELI's existing customers receive advanced written notice of the proposed d/b/a and is working closely with its customer base to avoid any customer confusion.³ Thus, the d/b/a name will not in any way harm or inconvenience ELI's customers or adversely affect ELI's managerial, technical, or financial resources.
