Dear Mr. Freed:

As you are aware, at the July 18, 2006 agenda conference, the Commission approved the issuance of Certificate No. 538-S to Zachary Taylor Camping and Lodge, Inc. and the authorization of rates and charges. A final order on the certificate will be issued within the next three weeks. After the order is issued, staff will forward the utility's certificate of authorization along with a letter summarizing matters of importance for new certificate holders and enclosing reference material.

The only remaining issue with regard to your application is the issuance of the utility's wastewater tariff. At the July 18th agenda conference, the Commission authorized the utility to charge each lot and common facility in the RV resort the same monthly flat rate it is currently charging each unit in Taylor Creek Condominium Association, i.e., \$23.10. This matter will be considered a proposed agency action in the order granting the certificate, which will then allow 21 days for a substantially affected party to protest the action. If the action is not protested, a Consummating Order will be issued.

Meanwhile, you will need to revise your proposed tariff to reflect the authorization of the monthly residential charge for the RV Resort lots. (A copy of your proposed tariff is enclosed with necessary changes marked.) The revised tariff should be filed directly with:
