Dear Mr. Duncan:

We have determined eligibility of Pinecrest Ranches, Inc., (Pinecrest) for a limited alternative rate increase (LARI). We find that the utility is eligible for a LARI.

The staff engineer has determined the filing fee in this LARI is \$500. The fee is based on the capacity of the utility systems as provided by Section 367.145(2) of the Florida Statutes. The filing fee must be received by August 18, 2006 which is the official filing date for this proceeding.

_____ revised schedules identified in the June 8th deficiency letter.

RCA _____ We have reviewed the revised MFRs submitted on June 19, 2006, and have determined that
SCR _____ the utility has met the minimum filing requirements imposed by Rule 25-30.457, F.A.C. Therefore,
SGA _____ pursuant to Rule 25-30.457(5), F.A.C., the official date of filing is established as August 18, 2006, and
_____ the 90 day timeframe pursuant to Rule 25-30.457(12), F.A.C. will begin on that date.
