

APPLICATION FOR TRANSFER OF FACILITIES TO GOVERNMENTAL AUTHORITY

Town and Country Utilities Company ("Town and Country") or ("Applicant"), pursuant to § 367.071, Florida Statutes, and Rule 25-30.037(4), Florida Administrative Code, files this application for approval of its transfer of a portion of the water facilities operated under Water Certificate No. 613-W in Charlotte and Lee Counties, Florida, and the deletion or cancellation of a portion of the water territory currently authorized under Certificate No. 613-W, and in support states as follows:

BACKGROUND

- 3. The transfer of facilities to governmental authority that is the subject of the instant application is one of a series of transactions which can be briefly summarized as follows:
 - (a) The Applicant is a wholly owned subsidiary of Babcock Florida Company (the

"Parent Company"). In July 2005, MSKP III, Inc. ("MSKP") entered into an Agreement whereby MSKP and the Parent Company would merge, with the Parent Company as the surviving entity (the "Merger Agreement"), and resulting in the acquisition of the Babcock Ranch ("The Ranch") and the Applicant by MSKP and its affiliates. The Ranch is 91,362 acres in total size of which approximately 81,499 acres are located in Charlotte County and approximately 9,863 acres are located in Lee County. The Ranch contains one of the single largest undeveloped tracts of land remaining in the State of Florida. The certificated water territory of the Applicant is The Ranch property. On July 27, 2006, MSKP filed an Application for Transfer of Majority Organizational Control of the Applicant. The Application is being processed by the Florida Public Service Commission (the "PSC") in Docket No. 060520. On July 31, 2006, the aforesaid merger was closed.

- (b) In November 2005, MSKP entered into an Agreement for Sale and Purchase with the Board of Trustees of the Internal Improvement Trust Fund of the State of Florida, the Florida Fish and Wildlife Conservation Commission, the Florida Department of Agriculture and Consumer Services, and Lee County, as purchasers of approximately 73,400 acres of The Ranch (5,620 in Lee County to be acquired by the County) for preservation purposes. This acquisition represents the single largest expenditure of State funds for acquisition of preservation lands in the history of the State of Florida. On July 31, 2006, this transaction was also closed. The instant application is being submitted for approval of the transfer of water facilities located within said 73,400 acres to the State of Florida and Lee County, pursuant to Section 367.071, Florida Statutes, and Rule 25-30.037(4), Florida Administrative Code. The effect of that transfer, upon PSC approval, would be the deletion of said 73,400 acres from the Applicant's certificated water territory.
- (c) Thereafter, the Parent Company and/or its affiliates retained ownership of approximately 18,200 acres in the southwest portion of The Ranch, known as "Area 6," for development purposes. The development is in the planning stages. At this time it is expected to include approximately 19,500 residential units; 6 million square feet of nonresidential space; (including hotel, office and retail) and golf course development (the "Project"). Project planning is currently underway and permitting will be initiated soon after the closing of the aforementioned purchases and sales, with an estimated demand date for utility service of June, 2010.
- (d) The Applicant intends, by a separate application, to seek certification as a wastewater utility within the said 18,200 acres, pursuant to Section 367.045, Florida Statutes, and Rule 25-30.033, Florida Administrative Code.
- (e) The instant application for transfer of water facilities to governmental authority is an essential element of the foregoing transactions and their associated applications to the PSC.

- (c) A copy of the Agreement for Purchase and Sale transferring the water facilities to the Purchasers will be made available for inspection by the Staff of the Florida Public Service Commission (PSC) at the offices of the undersigned counsel for the Seller.
- (d) A list of the Applicant's utility assets not transferred to the Purchasers is attached as Exhibit "A."
- (e) The Purchasers obtained from the Applicant the most recent available income and expense statement, balance sheet, statement of rate base for regulatory purposes, and contributions-in-aid-of construction.
- (f) The Purchasers' acquisition of the Applicant's water facilities under the aforesaid Agreement for Purchase and Sale closed on July 31, 2006.
- (g) Pursuant to its PSC water tariff, the Applicant does not require customer deposits. No disposition of such deposits and interest thereon is therefore necessary.
- (h) There are no fines owed relative to Applicant's water facilities. Applicant will continue to pay regulatory assessment fees in the ordinary course of business.
- 4. Since Applicant is transferring <u>a portion</u> of its facilities to the Purchasers, the following additional information is hereby submitted.
- (a) A description of the remaining territory using township, range and section references is attached as Exhibit "B."
- (b) The territorial map showing the remaining territory has been forwarded directly to Commission Staff as Exhibit "F."
- (c) The tariff sheet(s) revised to show the remaining territory are attached as Exhibit "D."
- 5. Pursuant to Section 367.071(3), Florida Statutes, no filing fee is required for this application, as the Purchasers are governmental authorities.
- 6. Pursuant to Section 367.071(4)(a), Florida Statutes, the instant transfer must be approved as a matter of right.

WHEREFORE, Town and Country Utilities Company respectfully requests that this Commission approve the transfer of its water facilities to the State of Florida and Lee County as

a matter of right, and the deletion or cancellation of a portion of its certificated territory for water service, and grant such other relief as is just and reasonable.
