ALLTEL Florida, Inc. has requested acknowledgment of a name change on ILEC Certificate No. 10 and PATS Certificate No. 5942 from ALLTEL Florida, Inc. to Windstream Florida, Inc. On July 14, 2006, Windstream Florida, Inc. and Windstream Communications, Inc., provided new labels for their respective tariffs reflecting the Windstream Florida, Inc. name (T060512) and the Windstream Communications, Inc. name (T060511), and requesting an effective date of July 17, 2006.

These name changes have been filed with the Florida Department of State, Division of Corporations. Since these name changes do not involve a transfer of certificate(s), staff recommends that the name change be acknowledged for IXC Registration No. TK045, and an administrative order be issued approving the name change for the ILEC and PATS Certificates, and the docket be closed.

As required in Section 2.07.C.2.a., Administrative Procedures Manual, this is to inform you that staff concurs with the name changes on ILEC Certificate No. 10, PATS Certificate No. 5942, and IXC Registration No. TK045.

On May 19, 2006, the Florida Public Service Commission ("FPSC" or "Commission") issued Order No. PSC-06-0425-PAA-TP ("PAA Order") approving the transfer of control of Alltel Florida, Inc. That Order became final on June 13, 2006. See Order No. PSC-06-0503-CO-TP. Footnote one of the PAA Order indicated that the name changes associated with the transaction would be handled administratively.

The change of control transaction is set to close on July 17, 2006. Consistent with the PAA Order, Alltel submits the following information and requests.

1. Effective July 17, 2006, Alltel Florida, Inc. requests that the name on ILEC Certificate No. 10 and pay telephone services Certificate 5942 be changed to Windstream Florida, Inc. The Company filed Articles of Amendment with the Secretary of State on June 26, 2006, to facilitate this name change. See Exhibit A.
2. Effective July 17, 2006, Alltel Holding Corporate Services, Inc. requests that the name on its IXC Certificate be changed to Windstream Communications, Inc. The Company filed the necessary papers to facilitate this change with the Secretary of State on May 4, 2006. See Exhibit B.
3. Enclosed with this letter are name change stickers that can be applied to Alltel Florida, Inc.'s General Subscriber Services Tariff and Access Services Tariff to reflect the name change to Windstream Florida, Inc. Alltel has coordinated the preparation of these stickers with Malinda Watts.
