This responds to your letter dated August 3, 2006, and provides you and Commission staff with an update on efforts by Four Points Utility Corporation ("Utility") to provide additional information pertaining to its application for original certificates to operate a water and wastewater utility in Polk County, Florida ("Application").

- 1. <u>Utility Accountant Retained</u>. As we have previously discussed, the Utility has retained Mr. Robert Dodrill to assist it with the certificate application, and to ensure that the books and records of the Utility are kept in compliance with the NARUC System of Accounts. Mr. Dodrill has reported that the conversion of the Utility's accounting system to the NARUC System of Accounts is underway and should be completed by August 18, 2006.
- 2. <u>Financial Ability Information</u>. Today, by separate filing, the Utility will file financial information that demonstrates that the Utility has the financial ability to provide water and wastewater service. This information is part of Exhibit "4" to its Application. Because it contains proprietary financial information relative to Mr. David Meadows, the sole shareholder of the Utility, the Utility will request confidential classification of that specific information.
- 3. <u>Billing Determinants</u>. Pursuant to your request, Mr. Dodrill is developing a schedule showing billing determinant data by month. That schedule should be completed and provided to you and staff by August 25, 2006.
