PLEASE TAKE FURTHER NOTICE that, pursuant to Section 2.01 of the JV Plan and paragraph 33 of the Confirmation Order, proofs of Administrative Expense Claims against the JV Debtors and requests for payment of such claims (unless excluded from such requirement pursuant to Section 2.01 of the JV Plan) must be filed with the Bankruptcy Court and served upon: (a) by overnight delivery, Adelpia Communications Corp., Claims Processing Center, c/o United States Bankruptcy Court, Southern District of New York, One Bowling Green, New York, NY 10004-1408; or (b) by first class mail, Adelpia Communications Corp. Claims Processing Center, P.O. Box 5059, Bowling Green Station, New York, NY 10274-5059, **so as to be received** no later than forty-five days after the Effective Date. **Any such Administrative Expense Claim not filed within such time will be forever barred from assertion against any of the JV Debtors, the Reorganized Debtors, the Transferred Joint Venture Entities or their property and the holder thereof shall be enjoined from commencing or continuing any action, employment of process or act to collect, offset or recover such Administrative Expense Claim.**

PLEASE TAKE FURTHER NOTICE that, pursuant to Section 10.03 of the JV Plan and paragraph 29 of the Confirmation Order, any Claim arising out of the rejection by the

JV Debtors under the JV Plan of an unexpired lease or executory contract must be filed with the Bankruptcy Court and served upon counsel to the Debtors (Willkie Farr & Gallagher LLP, 787 Seventh Avenue, New York, New York 10019, Attn: Shelley C. Chapman, Esq.) within 30 days after service of this notice. **All such Claims not filed and served within such time will be forever barred from assertion against the JV Debtors, the Affiliated Debtors, the Reorganized Debtors, the Transferred Joint Venture Entities or such entities' properties.**
