Dear Ms. Bayó:

On September 27, 2001, pursuant to Section 366.093, Florida Statutes, and Rule 25-22.006, Florida Administrative Code, Florida Power & Light Company ("FPL" or "Company") filed a formal request for confidential classification of FPL FiberNet material obtained during Audit No. 01-067-4-1, including Exhibits A-D. By Order No. PSC-02-0058-CFO-EI, issued January 7, 2002, and amended by Order No. PSC-02-0058A-CFO-EI, issued January 31, 2002, in Docket No. 011321-EI, confidentiality was granted for a period of 18 months. Confidentiality was first extended for a period of 18 months by PSC-03-0972-CFO-EI, issued August 28, 2003. Confidentiality was extended again for a period of 18 months by Order PSC-05-0368-CFO-EI, issued April 7, 2005.

Confidential classification will soon expire and FPL FiberNet has deemed that confidential treatment should be continued. Pursuant to Section 364.183(1), Florida Statutes, and Rule 25-22.006(5), Florida Administrative Code, FPL FiberNet claims confidentiality of the confidential materials included in Exhibit A to the September 27, 2001 request for confidential classification. Two edited versions of the confidential materials on which all confidential information has been redacted are included as Exhibit B to the September 27, 2001 filing.
