of a Water Utility Agreement entered into between Lake Utility Services, Inc. ("LUSI"), and Standard Pacific of Central Florida, for water service to the Foxchase Subdivision in Lake County, Florida. LUSI's water facilities currently have a total permitted capacity of 10,790 ERCs. The connected load for the current water treatment plant is approximately 8,270 ERCs. This Water Utility Agreement is for 162 ERCs for water. There is sufficient capacity in LUSI's existing water plant to provide water service pursuant to this Water Utility Agreement.
