## BELLSOUTH TELECOMMUNICATIONS, INC.'S PETITION TO CHANGE DEMARCATION POINT

BellSouth Telecommunications, Inc. ("BellSouth") hereby requests the Florida Public Service Commission ("Commission") to grant, pursuant to and as contemplated by Rule 25-4.0345(1)(b) ("the Rule"), Florida Administrative Code, permission for BellSouth to provide service at a different demarcation point, than as specified in the Rule, for basic local service to tenants at the commercial office campus at 18001 Old Cutler Road ("Building A"), 17901 Old Cutler Road ("Building B"), and 18101 Old Cutler Road ("Building C"), Miami, Florida 33157, (referred to jointly as the "Office Campus"), owned by 17777 Old Cutler Road, LLC ("Old Cutler"), for the reasons set forth below. Specifically, BellSouth seeks the following:

- 1. BellSouth is a local exchange company lawfully doing business in the State of Florida whose regulated operations are subject to the jurisdiction of this Commission pursuant to Chapter 364, Florida Statutes.
- 2. BellSouth's principal place of business is 675 W. Peachtree St., NE, Suite 4500, Atlanta, GA 30375. Pleadings and process may be served upon:

- 4. Rule 25-4.0345(1)(b), Florida Administrative Code, sets forth the required location, unless otherwise ordered by the Commission for good cause shown, for the point of physical interconnection between the telephone network and the customer's premises wiring, or the demarcation point.
- 5. Rule 25-4.0345(1)(b)(2) requires that the demarcation point for a single line/multi-customer building be located within the customer's premises at a point easily accessed by the customer.
- 7. Upon information and belief, Old Cutler owns the Office Campus, which consists of three main buildings, Buildings A, B and C. *See* Exhibit "A" attached hereto.
- 8. Upon information and belief, the Office Campus was once the corporate headquarters for Burger King Corporation, a single customer. *See* Exhibit "B" attached hereto.
- 9. On or about October 2003, the Office Campus was sold to Old Cutler. *See* Exhibit "A". Upon information and belief, the Office Campus has now been converted from a single tenant to a multi-tenant premises.

- 10. Old Cutler has requested a single point of demarcation for BellSouth services at the Office Campus to be located in the 3<sup>rd</sup> floor meter room located in Building A<sup>1</sup>. See Exhibit "C" attached hereto.
- 11. BellSouth fully supports the existing Rule but is requesting the approval for good cause in order to provide service to tenants at the Office Campus given Old Cutler's requested demarcation point.
- 12. Thus, to the extent BellSouth needs the Commission to approve a different demarcation point for basic local service to the Office Campus, this Petition requests approval for "good cause shown" under the Rule.

WHEREFORE, BellSouth requests that, having demonstrated good cause for the relief requested herein, the Commission grant its Petition.

Per Title 47 of the Code of Federal Regulations, Part 68.3, the Federal Communications Commission (FCC) requires telecommunications carriers to fully inform property owners of available options for location of the point(s) of service demarcation. The purpose of this letter is to provide you with such information and to serve as a record of your choice in this matter.

The above referenced rule permits the carrier to adopt a uniform policy of locating all tenants' service demarcation points at the Minimum Point of Entry (MPOE) of the property. If the carrier does not adopt such a policy, the property owner shall decide whether to:

- 1. Allow the carrier to establish multiple points of demarcation, each point typically located within each tenant's premises; or,
- 2. Require the carrier to locate all tenants' demarcation points at a single point on the property, typically at the MPOE.

BellSouth has not adopted a MPOE policy. Therefore, as the Property Owner or authorized agent of the Owner, you may choose one of the two options described above and listed below.
