Dear Mr. Cherry:

Pursuant to Order No. PSC-03-1119A-PAA-SU, issued November 10, 2003, in the above docket, Environmental Protection Systems of Pine Island, Inc. (EPS or utility) was ordered to complete construction and interconnection with the Pine Island Regional Treatment System (PIRTS) within nine months of the issuance of the Consummating Order, i.e., August 10, 2004. In a telephone conversation with staff, you indicated that EPS is now sending its wastewater to the county and that you have dismantled the wastewater treatment plant. Staff is requesting an update on the progress to date and that you provide the following information:

- 1) The actual date of the interconnection;
- 2) whether all charges for the items listed in number three below have been submitted to EPS; and
- 3) copies of invoices for the costs including but not limited to the actual cost to interconnect, including the cost of the new lift station, the cost to update lift station No. 2, the cost of dismantling the old plant, and the cost to inspect and test the collection system as required by PIRTS.
- 4) If the above projects have not been completed, please explain why and provide contracts or written estimates for their completion, and the expected completion date.


