NOTICE IS HEREBY GIVEN that the Florida Public Service Commission has received a petition from Town and Country Utilities Company, in Docket No. 060602-SU, seeking a temporary waiver of Rules 25-30.033(1)(k), (t), (u), (v), and (w), Florida Administrative Code. The petition requests that these portions of the rule, which address information required for setting initial rates in original wastewater certificate proceedings, be waived temporarily to permit bifurcation of the certification proceeding into an initial certification portion, followed at a later date by the rate setting portion of the proceeding.
