JOINT MOTION FOR EXTENSION OF TIME



("Supra"), pursuant to Rule 28-106.204(5), Florida Administrative Code, requests that the Florida Public Service Commission ("Commission") grant the parties an extension of time until October 13, 2006, in which to file their Direct Testimony. In support of this motion, BellSouth states the following:

1. Pursuant to the Order Establishing Procedure, issued on August 31, 2006, Order No. PSC-06-0738-PCO-TP, Direct Testimony is due on September 25, 2006.

3. Neither the parties nor Staff would be prejudiced by such an extension of time as the Rebuttal deadline is November 1, 2006.




