
AFFIDAVIT OF ROBERT ONSGARD

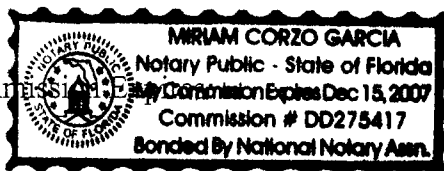
