Please accept this letter as a request to cancel the current Certificate for Alternative Local Exchange Services #8574, Company Code TX835 for alternative local exchange company services currently held by TWC Information Services (Florida), LLC. Pursuant to Rule 25-24.820 (Florida Administrative Code) TWC Information Services (Florida), LLC seeks to cancel its registration. Pursuant to that rule, TWC Information Services (Florida), LLC states as follows:
