On March 23, 2006, Docket No. 060273-TI was established to address the cancellation of Phone Interactive Communications Corp.'s intrastate interexchange telecommunications (IXC) Registration No. TI416 due to dissolution of the company. Order No. PSC-06-0658-PAA-TI was issued on August 4, 2006 and ordered that Phone Interactive Communications Corp.'s (IXC) tariff be canceled and its name removed from the register. The Commission further ordered that the 2005 and 2006 Outstanding Regulatory Assessment Fees (RAFs) for the company's IXC registration, including statutory late payment and interest charges for 1999 and 2005 shall not be sent to the Department of Financial Services for collection, instead permission for the Commission to write-off the uncollectible amounts will be requested.

Therefore, staff requests that Bureau of Administrative Services and Fiscal Services Section take the appropriate steps to seek permission from the Department of Financial Services to write-off the uncollectible RAFs for 2005 and 2006 and statutory late payment and interest charges for 1999 and 2005 for Phone Interactive Communications Corp.
