Dear Mr. Friedman:

On September 19, 2006, the Commission voted on staff's recommendation dated September 7, 2006. The Order was issued on October 6, 2006. If no protests are filed by the end of the protest period, which is 21 days from the date that the order is issued, the charge approved by this Commission will become final. However, a copy of the customer notice informing the utility's customers of the Commission's approved increase must be submitted for staff's review and approval.

To expedite the process, the utility should file a copy of the customer notice by November 3, 2006, to allow staff sufficient time to verify the accuracy of the customer notice. Enclosed is an example of a customer notice for this utility. Although staff has prepared an example of the customer notice, it is the utility's responsibility to make sure the information submitted to the Commission is complete and accurate.

After staff approves this notice, it must be mailed to customers of receipt prior to the late payment charge becoming effective.


