If fact everyone in sight has power onelectricity is rampant throughout the neighborhoodthe Gulf Power representative again said No, not you lady...it will take two weeks at least. We cant help you get on the list. Can you imagine my fear and anger? I was astonished that in this age of computers and communications, that Gulf Power, in all of its ability, could not confirm my dilemma and at the very least offer me some ray of hope and understanding. Could not offer me any words of encouragementI never felt so defeated. I got thru to the credit union people, explained my situation and asked them to call a human and explain, as we both knew, as you know, they were certainly helping and bumping up the list for service for family. I continued to pursue and employ all with the facts Im a stockholder, my father worked there from college to gravestill the only response was Sorry...it will take two weeks at least.

I think it was the next day as I awoke in my APARTMENT WITH NO ELECTRICITY, WHERE NEXT DOOR AND BEHIND ME THERE IS ELECTRICITY, IN THE VERY SAME COMPLEX. I just cried again. I had my door open so as to get some air and I see a convoy of Gulf Power company trucks coming down the road, 72nd Ave just off Hwy 98. God is good! In my gown and robe, I rush out into the street and hold up my arms and wave. They STOPI blurt out, Can you help me? I am a member of the family, a part of the team, a stock holderPlease! I am crying for real now as I am lucky, I did not get hit in the road. I explain my plight and they respectfully listen as they get out of the truck and stop the convoy. Wheres the meter? I show them where there are three meters in a row, two spinning and one flat...BINGO; the headman flips some switch and VIOLA!!! Action, Power, Lights, the meter starts. Pretty simple...for that I was to wait two weeks.

Gulf Powers restoration services could be enhanced, a tremendous benefit to persons like me forced into circumstances beyond their control. There needs to be a way for some form of priority to be applied. A team could be in force under similar circumstances to address these particular circumstances and issues. I make reference to page 09 of FRONT AND CENTER Southern Companys 2005 annual report as a guide for my request to have the issue of hurricane power connection for customers such as me as regards hurricane damage and continuing to live with electrical power. Lets take some of this money and really help the customer who so needs help If in reality it cant be done at least turn that party over to a specially trained representative who can explain, comfort, assuage and mold the truth in such a way as to enhance not further the anguish. I thank-you for your time and attention.

ITEM 3:

DOCKET NO. 060172-EU – PROPOSED RULES GOVERNING PLACEMENT OF NEW ELECTRIC DISTRIBUTION FACILITIES UNDERGROUND, AND CONVERSION OF EXISTING OVERHEAD DISTRIBUTION FACILITIES TO UNDERGROUND FACILITIES, TO ADDRESS EFFECTS OF EXTREME WEATHER EVENTS.

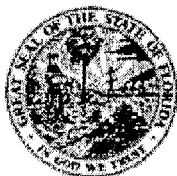

PSC Approves Gulf Power Settlement

TALLAHASSEE — The Florida Public Service Commission (PSC) voted on Tuesday to approve a settlement agreement in Gulf Power Company's (Gulf) storm recovery financing petition.

The settlement provides for the continuation of Gulf's current hurricane recovery surcharge through June 2009. For residential customers using 1,000 kWh, the charge is \$2.57. The extension will allow Gulf to replenish its storm reserve and recoup its storm recovery costs associated with Hurricanes Ivan, Dennis, and Katrina.

"This Commission has a long standing policy of encouraging the settlement of contested proceedings in a manner that benefits the ratepayers," Commission Chairman Lisa Polak Edgar said. "The agreement approved today balances the various positions of the parties and serves the best interests of Gulf's customers."

Gulf serves approximately 394,772 retail customers between the Alabama border and the Apalachicola River. In all, Gulf Power serves customers in 71 cities and communities in Florida.
