Dear Mr. Friedman:

By Order No. PSC-04-1281-PAA-WS, issued December 28, 2004, the Commission required Labrador Utilities Inc. to test all of its customers' water meters. The total meters required to be tested was 903. In a letter date June 23, 2006, Labrador submitted a report showing the results of testing 800 meters. Staff reviewed the data contained in the report and questioned the meter test dates shown in the report. On November 2, 2006, the utility informed staff that it had submitted an incorrect report. On November 6, 2006, staff received two e-mails from the utility, each containing an attached file with results of the meter testing. In one report, the utility listed 515 meters tested and the other reflected 800 meters tested.

Pursuant to Order No. PSC-04-1281-PAA-WS, the utility is required to test all of its customers meters. Based on the reports submitted as of November 8, 2006, it does not appear that the utility has complied with the requirements of Order No. PSC-04-1281-PAA-WS.
