HQ Global Workplaces, Inc. ("HQ"), by its undersigned counsel, and in accordance with the above-referenced Commission's Order, hereby submits the following: (1) HQ is a registered Interexchange (IXC) and Shared Tenant Service provider in the State of Florida under the following registration numbers: TJ741 and TS200; and (2) because it does not pay any access charges directly to local exchange carriers, its intrastate switched access expense reduction is \$100 or less per month. As such, it is not obligated to flow through any reduction in intrastate switched access charges and is not subject to the above-referenced Order's tariff revision requirements.

Please note that HQ is in the process of reviewing its operations in Florida in order to determine what, if any, regulated telecommunications services it provides in the State.
