Dear Ms. Bayo:

Qwest Interprise America, Inc. ("QIA"), formerly known as U S WEST Interprise America, Inc., (U S WEST Interprise) submits this letter to the Commission to express its intentions to voluntarily cancel its Certificate No. 4429 to provide alternative local exchange telecommunications services in Florida.

According to our records, in Florida, QIA had been granted Certificate No. 4429 to provide alternative local exchange telecommunications service in the State of Florida by Order PSC-96-0613-FOF-TX (05/07/96), Docket No. 960110-TX.

Accordingly, QIA with this letter cancels the aforementioned certificate, without prejudice. Pursuant to Fla. Admin. Code §25-24.820(2), QIA provides the following information:

- (a) QIA intends to pay any unpaid Florida regulatory assessment fees by January 30, 2007.
- (b) QIA proposes to cancel Certificate No. 4429 because QIA no longer has any telecommunications services customers or facilities in Florida, and does not intend to offer telecommunications services in the future under Certificate No. 4429.
- (c) Since QIA no longer has any telecommunications services customers in Florida, all customer deposits have been returned and all final bills have been rendered.
- (d) Since QIA no longer has any telecommunications services customers or facilities in Florida, no discontinuance of service is associated with this cancellation and it is unnecessary to provide any individual customer notice regarding discontinuance of service.

If any further action or information is required to accomplish this cancellation, please contact me at your earliest convenience.
