Staff requests permission to make an oral modification to its recommendation for Docket No. 060647-EG, which the Commission will address as Item 11 at the November 21, 2006, Agenda Conference. Staff would like to modify the recommendation statement and staff analysis in Issue 2, as shown below in legislative format:

Issue 2: Should this docket be closed?

Recommendation: Yes. If Issue 1 is approved, the tariffs should become effective November 21, 2006 August 31, 2007. If a protest is filed within 21 days of the issuance of the order, the tariff should remain in effect with any increase held subject to refund pending resolution of the protest. If no timely protest is filed, the docket should be closed upon the issuance of a consummating order. (Fleming)

Staff Analysis: If Issue 1 is approved, the tariffs should become effective November 21, 2006 August 31, 2007. If a protest is filed within 21 days of the issuance of the order, the tariff should remain in effect with any increase held subject to refund pending resolution of the protest. If no timely protest is filed, the docket should be closed upon the issuance of a consummating order.
